- The aim of the project is for each state and territory:
  - To identify the situation of older people living in potentially precarious housing situations and at risk of homelessness;
  - To identify the housing options and services that currently exist and the issues around housing supply and the capacity of services to meet people's needs;
  - Starting the conversations for systemic change across all tiers of government and the community sector.






 Reductions in home ownership over the last 25 years across the age spectrum; impacting on housing tenure



## Per cent change over time in the number of low income households aged 65+ receiving CRA, paying more than 30% income in rent






#### **Older people and housing stress**



The number of low income households aged 65 years and over in the Greater Sydney Region paying more than 30 per cent of household income in rent, March 2017.






#### **Older people and housing stress**

#### What we found



- Older people are often traumatised in housing stress
- Problem of the private rental market
- A complex housing system to navigate and a maze of retirement housing options
- Difficult for older people to get information, support and advocacy
- Eligibility for public and community housing unfair at 80 years of age
- Housing supply for an ageing population


