Our Annual General Meeting will be held on 17th November 2016 at 11.00am – 1.00pm. Elections for office bearers will take place at this meeting. All members are eligible to nominate and vote.

STRATEGIC PLANNING

After nine months of consultation, the three year strategic plan for Housing for the Aged Action Group has been finalised and approved by the Committee of Management. This will guide the work of the organisation for the next three years. Highlights from the plan include encouraging more members to join working groups, and supporting members to lobby their politicians about housing for older people. We would also like to increase the number of members from culturally and linguistically diverse backgrounds, to reflect our client group, and from regional areas. Our hope is that we will expand and improve our support for members and volunteers over the next three years. The strategic plan also includes plans for increasing our public profile, and continuing to provide a quality service to older people at risk of homelessness.

Parliamentary inquiry into retirement housing – update

The parliamentary inquiry into retirement housing, being conducted by the Legal and Social Issues Committee of the Victorian Legislative Council, has completed its first phase which requested submissions from the public around a range of issues related to retirement housing.

Thank you to the HAAG members that responded with individual submissions. The inquiry has received approximately 800 submissions which is a phenomenal response.

The next phase of the review will involve the committee holding public hearings where they can interact directly with organisations and individuals who submitted responses to find out more about the key issues and recommendations to consider in their final report.

RESIDENTIAL TENANCIES ACT (RTA) REVIEW - UPDATE

The second phase of the RTA review, driven by Consumer Affairs Victoria (CAV), has come to a close. The second phase of the review involved the release, and subsequent response to, 6 issues papers:

- Security of tenure,
- Rent, bonds and other charges,
- Rights and responsibilities,
- Dispute resolution,
- Property standards and conditions, and;
- Alternative forms of tenure

For the next phase of the review CAV will release an options paper which will propose possibilities for change and this paper will be open for public response. The paper is due to be released towards the end of 2016.

In the lead up to the release of the options paper HAAG is also involved in an Residential Tenancies Act reference group initiated by Consumer Affairs Victoria.

LAUNCH SITES

Three sites across Victoria have been chosen to launch "a new way of working" across the housing and homelessness systems in partnership with local community organisations. The three areas are Inner Gippsland, Brimbank-Melton and Hume-Moreland.

This is happening because the current system is fragmented, disconnected and can't keep up with demand, making it hard for people to get the help they need. The reform is in line with the recommendations from the Royal Commission into Family Violence.

Housing for the Aged Action Group is participating in the Brimbank-Melton launch site reform. The government is asking us to :

- Contribute and provide expert advice
- Lead and implement changes in our organisation including working with our local DHHS office and other stake holders
- Provide regular feedback and reporting

Recently, Launch Site Facilitators were employed by DHHS to lead the process, and we are expecting to be part of an area implementation group soon. We can only hope that this reform will lead to a better experience for older people who access the homelessness and housing services.

HOMFI FSSNESS WEFK 2016: RALLY AND REPORT RELEASED

On 1 August, Housing for the Aged Action Group members and staff braved the weather to rally in the city for Homelessness Week. The rally drew attention to the "Hidden homeless" – older women living in private rental. We handed out around 100 copies of our "Older People & Housing" fact sheets and marched from Fed Square up Swanston St to the Town Hall with our placards and new megaphone. Chairperson Daisy Ellery made a speech. It was a great effort from our members, despite the wet and cold weather.

We released a report on the day – *At the Crossroads: Older people at risk of homelessness*. This contained data on the first two years of our service, which has seen over 2000 people, 60% of them older women, and over half in expensive private rental. A quarter of people contacting the service have already been evicted, and are couch surfing, house sitting or living with friends or family.

The report garnered lots of attention, and resulted in interviews with RN Breakfast and News Radio which was heard all over Australia, and an article in The Senior in September. People who heard the story on radio then got in contact with Home at Last, which has led to more media and other opportunities. HAAG were invited to attend a meeting in Canberra with Equality Rights Alliance, a national network of 61 organisations, to discuss older women and housing. We have also been contacted by groups, including universities, from Tasmania, NSW and WA requesting the report.

The rally and report also received lots of social media attention. The photograph of our committee member Sally Stabback was very popular indeed, and was seen over 7000 times on Twitter! The report and more photographs from the rally can be seen on our website.

















GENERAL EXEMPTION ORDER (GEO) REVIEW

The GEO provides exemption categories in relation to entities that provide electricity to a defined group of customers and/or as an incidental to their main business. This means certain entities are not required to apply for a license to sell and supply electricity and they are exempt from certain aspects of regulation. It also means the services of the Energy and Water Ombudsman of Victoria (EWOV) are not available to customers of exempt suppliers.

Embedded electrical networks provided in caravan and residential parks (and also often in retirement villages) are covered by the GEO. Therefore the rights and protections of residents, as the third party to an energy arrangement, are not clear or robust.

The Department of Environment, Land, Water and Planning (DELWP) launched a review of the GEO in 2015 requesting submissions as to what amendments were required in this area to improve consumer protections.

HAAG submitted a response focusing on exemptions granted to caravan and residential park owners and operators supplying and on-selling electricity through an embedded network, and the consequent impact on long term tenants and residents This year DELWP released a draft position paper proposing recommendations for changes to the GEO. HAAG submitted a response and was mostly in support of the recommendations outlined in the paper. TRUST FUNDING



We take this opportunity to announce and gratefully acknowledge recent grants HAAG has received from two Philanthropic Trusts. We have received \$9,000 from The Lord Mayor's Charitable Foundation – Youth in Philanthropy Program, and \$5,000 from Street Smart Australia.

The funding will be used to assist our Home at Last outreach clients move into long term housing. Grants we receive are used in a very practical way that enables people to establish and maintain their new housing. Some of the things grants pay for are rent in advance, removal costs, packing, and where necessary the purchase of beds, white goods and household items. On average our service successfully houses 10 people per month and without this type of financial assistance all would remain either homeless, or would remain living in dire housing circumstances. Thank you to both Trusts for your generous donations and for supporting both our work and clients.

A HOME FOR DIVERSITY

'A Home for Diversity' was a 6 month project that aimed increase the capacity of homelessness services to work with people from culturally and linguistically diverse (CALD) backgrounds. The project provides training to housing workers, particularly those who work with older people. This training was provided by the Centre for Culture, Ethnicity and Health, in collaboration with Housing for the Aged Action Group and ran from July to August 2016.

In the process of gathering information to inform the contents of the training package, a number of stakeholders were consulted. These were, a Community Reference Group, a Housing and Homelessness Sector Reference Group, interviews with 5 services users and a survey of Housing and Homelessness workers with 89 responses.

A report has been created in response to the valuable and comprehensive information provided by these stakeholders, particularly on the ability of the Housing and Homelessness sector to respond to the needs of people from Culturally and Linguistically Diverse backgrounds.

The project undertook to engage stakeholders in housing and homelessness sector and the ethno-specific service sector, in order to create and deliver a training program that will increase the capacity of housing and homelessness workers to work with people from diverse cultural backgrounds.

Through its partnership with HAAG, the Centre for Culture, Ethnicity and Health (CEH) have delivered 6 tailored training sessions as part of the project. The outcomes of these sessions will be measured by CEH into the future, but feedback so far has indicated that participants have found the training useful and practical and many stated their intention to change their individual practice and/or procedures in their agencies.

Without knowledge and understanding of the diverse migration histories and cultural values and practices of Australia's multicultural communities, services will not be culturally inclusive and responsive to the complex needs of clients from culturally diverse backgrounds. HAAG believes that this project has gone some way in providing a foundation for structural changes to how services are delivered, so that clients from culturally diverse backgrounds can have more equitable access to housing and homelessness services.

Housing for the Action Group was keen for the important learnings from the project to be shared with other housing services, so that access to housing services for older CALD people could be improved. We hope this information has been valuable for both service providers and relevant government and funding bodies.

INDEPENDENT VOICES: COLLECTING AND rECORDING THE EXPERIENCES OF residents of not-for-profit retirement villages

I had the enviable job of travelling to suburbs, regional towns and rural villages in Victoria to meet with older people living in not-for-profit Independent Living Units (ILUs). But people were hesitant to get in touch with me. When I was inviting people to interview, many expressed fear that speaking out could compromise their relationships with management or their security of tenure. This fear tells us something is wrong with residents' experiences of the atmosphere or culture of their ILU clusters and villages.

We needed to find out more. Housing provision for older people must have the wellbeing of older people at its core. This project was instigated in the recognition that older people deserve dignity and quality of life in their housing, and to live free of fear.

In the final report, residents' views and experiences are written up and I have drawn recommendations for improving ILUs from this learning. There are five thematic areas: residents views of ILUs and the retirement housing sector; what contributes to a good quality of life; legal issues which have arisen for residents, and governance. The research also explores some issues around the current state of the housing stock. The Launch of 'Independent Voices'

HAAG hosted the launch of our new report on the 26th July at the Multicultural Hub on Elizabeth St in the city.

HAAG's Chair Daisy Ellery opened the event by welcoming everyone. She explained that the project had come about as low-income residents of ILUs were approaching the organisation with stories of exploitation and mistreatment. HAAG's retirement housing Officer Shanny Gordon and HAAG's Independent Living Unit Working Group wanted to see if their experiences were shared by other ILU residents across Victoria.

Daisy thanked the many people who contributed to the project, the author Aoife Cooke, Shanny Gordon and the members of the ILU Working Group; Loc Tran, Akeeb Abao, Kirsten Day, Naseem Ahmadpour and Alen Kiernan of the Centre for Design Innovation at Swinburne University. Thank you also to Denise Boyd of the Consumer Action Law Centre. Aoife Cooke then spoke, and outlined some findings from the report, which are also included in this newsletter. She was followed by the Hon. Marlene Kairouz, Minister for Consumer Affairs, Gaming and Liquor Regulation. We are grateful to the Minister for joining us and addressing our gathering for the event.

The next speaker was Kerryn Jones from the funders for this project, the Lord Mayor's Charitable Foundation. She is the Program Manager for Homelessness & Affordable Housing, and spoke of their support for HAAGs work, and the importance of older people's housing.

Our final three speakers were Barney de Wit, Kathy Barnes and Vicki Gutsjahr, members of the Independent Living Unit Working Group. They presented case studies from the report – stories of the difficulties that residents of ILUs are encountering. These stories, like many of the case studies and quotes in the report, show us the human impact of weak regulation, bad management practices and the strain of unaffordable housing. Thankfully, the report also highlights the positive aspects of life in an ILU.

We closed the launch with presentations of chocolates to the speakers and a beautiful bunch of flowers to Aoife to say thank you for all her hard work. We then enjoyed tea, cakes and conversation – something HAAG always does excellently!




